- b. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security equivalent to thirty percent (30%) of the total contract price (₱ 418,844.10); or
- c. Performance Securing Declaration (PSD) as provided under the Revised Implementing Rules and Regulations of Republic Act No. 9184.

Failure to provide the performance security shall constitute ground for cancellation of the award and forfeiture of the bid security.

WHEREAS, the Philippine Normal University, in compliance with RA 9184, posted/advertised the Invitation to Bid for the Supply, Delivery, and Installation of PNU Back-Up Internet Service Provider on January 20, 2022-February 9, 2022 in PhilGEPS, PNU BAC Bulletin Board and PNU Website with an approved budget of One Million Four Hundred Thousand Pesos (Php 1,400,000.00); for the contract;

WHEREAS, a Pre-Bid Conference was conducted last 26 January 2022 (Wednesday) virtually via Zoom application, wherein three (3) interested suppliers attended the Conference, namely:

WHEREAS, the Regular Bids and Awards Committee (BAC) has scheduled and conducted the Opening of Bids on 9 February 2022 (Wednesday) at 2:00 PM held at the PNU Alumni Relations Hall;

WHEREAS, during the scheduled Opening of Bids, only one (1) supplier bought the Official Bid Documents, and submitted Bids, namely: Converge ICT Solutions, Inc.;

WHEREAS, the summary of the Opening of Bids are as follows:

WHEREAS, during the detailed Technical Evaluation conducted by the Technical Representative, Converge ICT Solutions, Inc. complied and satisfied all the requirements specified in Section VII. Technical Specifications of the bidding documents;

WHEREAS, upon arithmetical computation, Converge ICT Solutions, Inc.'s Financial Bid amounting to One Million Three Hundred Ninety-Six Thousand One Hundred Forty-Seven Pesos (₱ 1,396,147.00) with an equivalent of 0.28% (₱ 3,852.92) variance from the ABC was then declared as the Single Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, on 2 March 2022 (Wednesday), the BAC, Technical Working Group (TWG), and BAC Secretariat conducted the Post Qualification assessment on the submitted bids by Converge ICT Solutions, Inc., and was found to have complied with all the requirements and conditions specified in the bidding documents and have passed the post qualification after having verified, validated and ascertained its bid documents;







KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made the APR 01 2022, 2022 between the **PHILIPPINE NORMAL UNIVERSITY (PNU)** of the Philippines represented herein by its President **Dr. BERT J. TUGA**, with Office address at PNU, Taft Avenue, City of Manila, hereinafter called the "**ENTITY**" of the one part and **CONVERGE ICT SOLUTIONS, INC.** represented by its Chief Operations Officer, **Mr. JESUS C. ROMERO**, duly organized and existing by virtue of the laws of the Republic of the Philippines with office address at New Street Bldg., Mac Arthur Highway, Balibago, Angeles City, Pampanga, hereinafter called the "**SUPPLIER**" of the other part.

WHEREAS, PNU intends to subscribe a high speed internet service connection for the Year 2022;

WHEREAS, internet service is vital and critical to the success and continuity of the operation of the University;

WHEREAS, PNU requires a back-up internet connection with a bandwidth of 500 MBPS that could set up a fast access internet service to facilitate the PNU Web-Based Systems, Web Portal Resources, Online Education and other programs crucial to the academic and administrative operations of the University; and

WHEREAS, the Entity invited Bids for **Supply, Delivery, and Installation of PNU Back-Up Internet Service Provider (GD 2022-01-002)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Ninety-Six Thousand One Hundred Forty-Seven Pesos (₱ 1,396,147.00)**, hereinafter called the "**CONTRACT PRICE**".


