WHEREAS, upon arithmetical computation, **Libtech Source Philippines, Inc.**'s Financial Bid amounting to **Four Hundred Thousand Pesos (₱ 400,000.00)** with a total equivalent of 13.16% ((**₱ 60,625.00**) variance from the ABC for was then declared as the Lowest Calculated Bid for Lot 1, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, upon careful examination, verification and validation of the eligibility, technical and financial requirements submitted by **Libtech Source Philippines, Inc.**, its bid of **Four Hundred Thousand Pesos (₱ 400,000.00)** was found to be responsive;

WHEREAS, upon careful examination, verification and validation of the eligibility, technical and financial requirements submitted by **EBSCO International, Inc.**, its bid of **One Million Three Hundred Eighty-Four Thousand Eight Hundred Fifty-Three Pesos and Ninety-Three Centavos (₱ 1,384,853.93)** was found to be responsive;

NOW, THEREFORE, WE, the Members of the Regular Bids and Awards Committee do hereby RESOLVE as it is hereby RESOLVED:
