- b. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security equivalent to thirty percent (30%) of the total contract price (₱ 362,260.74); or
- c. Performance Securing Declaration (PSD) as provided under the Revised Implementing Rules and Regulations of Republic Act No. 9184.

WHEREAS, the Philippine Normal University, in compliance with RA 9184, posted/advertised the Invitation to Bid for the **Upgrading of Electrical Panel for ACU at Alumni Hall and Auditorium at Pecson Hall and at Library Third Floor** on July 4-25, 2022 in PhilGEPS, PNU BAC Bulletin Board and PNU Website with an approved budget of **One Million Two Hundred Forty-Six Thousand Fifty-Eight Pesos and Eighty-Three Centavos (Php 1,246,058.83)** for the contract;

WHEREAS, a **Pre-Bid Conference** was conducted last **11 July 2022 (Monday)** virtually via Zoom application, wherein four (4) interested contractors attended the Conference, namely:

WHEREAS, on 26 July 2022 (Tuesday), Global Empire International Group of Companies, Inc. filed a Motion for Reconsideration and, upon thorough review of the BAC, was later granted on 28 July 2022 (Thursday) and acknowledged receipt by the said bidder on 29 July 2022 (Friday) thru email;

WHEREAS, the Regular Bids and Awards Committee (BAC) has scheduled and conducted the **Opening of Financial Proposal of Global Empire International Group of Companies, Inc.** on 3 August 2022 (Wednesday) at 9:00 AM held at the Pedro T. Orata Hall (Room 103);

WHEREAS, Global Empire International Group of Companies, Inc.'s Financial Bid amounted to **Nine Hundred Seventy-Three Thousand Nine Hundred Eighty Pesos and Four Centavos (₱ 973,980.04)**;

WHEREAS, during the Technical Evaluation conducted by the Technical Representative, **Global Empire International Group of Companies, Inc.** failed to comply and satisfy the Eligibility Documents, particularly the requirements specified in Section VIII. Bill of Quantities and Other Requirements;

WHEREAS, on **22 August 2022 (Monday)**, **Global Empire International Group of Companies, Inc.** was formally issued a Notice of Non-Compliance thru email which was subsequently acknowledged receipt by the said bidder on **9 September 2022 (Friday)** also thru email;

WHEREAS, on **9 September 2022 (Friday)**, **Global Empire International Group of Companies, Inc.** filed a Motion for Reconsideration and, upon thorough review of the BAC, was later denied on **13 September 2022 (Wednesday)** and acknowledged receipt by the said bidder on **14 September 2022 (Wednesday)** thru phone call;

WHEREAS, during the detailed Technical Evaluation conducted by the Technical Representative, **Grandstar General Contractor** complied and satisfied all the requirements specified in Section VII. Technical Specifications of the bidding documents;

WHEREAS, upon arithmetical computation, **Grandstar General Contractor's** Financial Bid amounting to **One Million Two Hundred Seven Thousand Five Hundred Thirty-Five Pesos and Eighty-One Centavos (₱ 1,207,535.81)** with an equivalent of 0.22% (**₱ 2,756.63**) variance from the ABC was then declared as the Lowest Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, on **16 September 2022 (Friday)**, the BAC, Technical Working Group (TWG), and BAC Secretariat conducted the Post Qualification assessment on the submitted bids by **Grandstar General Contractor**, and was found to have complied with all the requirements and conditions specified in the bidding documents and have passed the post qualification after having verified, validated and ascertained its bid documents;

WHEREAS, upon careful examination, verification and validation of the eligibility, technical and financial requirements submitted by **Grandstar General Contractor**, its bid of **One Million Two Hundred Seven Thousand Five Hundred Thirty-Five Pesos and Eighty-One Centavos (₱ 1,207,535.81)** was found to be responsive; and

NOW, THEREFORE, WE, the Members of the Regular Bids and Awards Committee do hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. That **GRANDSTAR GENERAL CONTRACTOR** be declared as the Lowest Calculated Responsive Bid, in consideration of its total amount of Bid equal to **One Million Two Hundred Seven Thousand Five Hundred Thirty-Five Pesos and Eighty-One Centavos (₱ 1,207,535.81)**;
- b. That we, the members of the Bids & Awards Committee (BAC), as per University Memorandum No. 082, Series of 2022 dated 17 May 2022, recommends to the Head of the Procuring Entity (HoPE) to award the Contract as detailed in this BAC Resolution; and
- c. That, a **Notice of Award (NOA)** be issued to **GRANDSTAR GENERAL CONTRACTOR**, upon adoption and approval of this BAC Resolution.



CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

20 OCT 2022

THIS AGREEMENT, made this _____ day of _____, 2022 between the **PHILIPPINE NORMAL UNIVERSITY (PNU)** represented herein by its President **Dr. BERT J. TUGA**, with Office address at PNU, Taft Avenue, City of Manila, hereinafter called the "**ENTITY**" and **GRANDSTAR GENERAL CONTRACTOR** represented by its General Manager/Proprietor/Authorized Managing Officer, **Mr. ELMER R. ESTRELLA**, duly organized and existing by virtue of the laws of the Republic of the Philippines with office address at No. 125 Ma. Clara Street, 7TH Ave, Grace Park, Caloocan City, hereinafter called the "**CONTRACTOR**".

WHEREAS, PNU continuously seeks to enhance the aesthetics of its classrooms, offices and facilities;

WHEREAS, these offices have to be conducive for work, small group discussions, and to achieve this is to install various brand new air-condition units;

WHEREAS, defective air-condition units of the University are already beyond repair and needed to be replaced;

WHEREAS, Panel Mounted Air Conditioner are utilized to dissipate heat generated by AC / DC Drives, Electrical/ Electronic components inside a control panel due to the working environment being hot, humid and dirty, to avoid entry of dust dirt and moisture inside the sealed panel for the use of ambient air be refrained; and

WHEREAS, the Entity is desirous that the Contractor execute **Upgrading of Electrical Panel for ACU at Alumni Hall and Auditorium at Pecson Hall and at Library Third Floor (CW 2022-06-004)** hereinafter called the "**WORKS**" and the Entity has accepted the Bid for **One Million Two Hundred Seven Thousand Five Hundred Thirty-Five Pesos and Eighty-One Centavos (P 1,207,535.81)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- iv. General and Special Conditions of Contract;
- v. Supplemental or Bid Bulletins, if any;

- (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security;
- (d) Notice of Award of Contract and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Million Two Hundred Seven Thousand Five Hundred Thirty-Five Pesos and Eighty-One Centavos (P 1,207,535.81)** or such other sums as may be ascertained, **Grandstar General Contractor** agrees to **Upgrading of Electrical Panel for ACU at Alumni Hall and Auditorium at Pecson Hall and at Library Third Floor** in accordance with his/her/its Bid.
4. The **Philippine Normal University** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






