- c. Performance Securing Declaration (PSD) as provided under the Revised Implementing Rules and Regulations of Republic Act No. 9184.

**WHEREAS**, a **Pre-Bid Conference** was conducted last **17 March 2022 (Thursday)** virtually via Zoom application, wherein three (3) interested suppliers attended the Conference, namely:

**WHEREAS**, the Technology-Related Bids and Awards Committee (BAC) has scheduled and conducted the **Opening of Bids** on **30 March 2022 (Wednesday)** at 10:00 AM held at the PNU Alumni Relations Hall;

**WHEREAS**, during the scheduled Opening of Bids, only one (1) supplier bought the Official Bid Documents, and submitted Bid, namely: **Kollab Guru Group, Inc.**;

**WHEREAS**, upon arithmetical computation, **Kollab Guru Group, Inc.**'s Financial Bid amounting to **One Million Seven Hundred Seventy-Two Thousand Four Hundred Pesos (₱ 1,772,400.00)** with an equivalent of 38.88% (**₱ 1,127,600.00**) variance from the ABC was then declared as the Single Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

TY**, duly organized and existing by virtue of the laws of the Republic of the Philippines with office address at BSA Twin Towers, Bank Dr., Ortigas Center, Mandaluyong City, hereinafter called the "**SUPPLIER**" of the other part.
