- c. Performance Securing Declaration (PSD) as provided under the Revised Implementing Rules and Regulations of Republic Act No. 9184.

Failure to provide the performance security shall constitute ground for cancellation of the award and forfeiture of the bid security.

WHEREAS, the Philippine Normal University, in compliance with RA 9184, posted/advertised the Invitation to Bid for the **Supply, Delivery, Configuration, and Installation of Building Management System** on November 29-December 19, 2022 in PhilGEPS, PNU BAC Bulletin Board and PNU Website with an approved budget of **Twenty-Four Million Nine Hundred Ninety-Six Thousand Nine Hundred Ninety-Nine Pesos (Php 24,996,999.00)** for the contract;

WHEREAS, a **Pre-Bid Conference** was conducted last **6 December 2022 (Tuesday)** virtually via Zoom application, wherein one (1) interested supplier attended the Conference, namely:

WHEREAS, the Regular Bids and Awards Committee (BAC) has scheduled and conducted the **Opening of Bids on 19 December 2022 (Monday)** at 9:00 AM held at the Pedro T. Orata Hall (Room 103);

WHEREAS, during the scheduled Opening of Bids, two (2) suppliers bought the Official Bid Documents, and submitted Bid, namely: **Pinnacle Technologies, Inc.** and **Amellaer Solutions**;

WHEREAS, the summary of the Opening of Bids are as follows:



WHEREAS, during the detailed Technical Evaluation conducted by the Technical Representative, **Pinnacle Technologies, Inc.** complied and satisfied all the requirements specified in Section VII. Technical Specifications of the bidding documents;

WHEREAS, upon arithmetical computation, **Pinnacle Technologies, Inc.'s** Financial Bid amounting to **Twenty-Four Million Nine Hundred Sixty-Eight Thousand Pesos (P 24,968,000.00)** with an equivalent of 0.12% (**P 28,999.00**) variance from the ABC was then declared as the Lowest Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, on **26 January 2023 (Thursday)**, the BAC, Technical Working Group (TWG), and BAC Secretariat conducted the Post Qualification assessment on the submitted bids by **Pinnacle Technologies, Inc.**, and was found to have complied with all the requirements and conditions specified in the bidding documents and have passed the post qualification after having verified, validated and ascertained its bid documents;

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made the APR 04 2023 day of CALOOCAN CITY, 2023 between the **PHILIPPINE NORMAL UNIVERSITY (PNU)** of the Philippines represented herein by its President **Dr. BERT J. TUGA**, with Office address at PNU, Taft Avenue, City of Manila, hereinafter called the **"ENTITY"** of the one part and **PINNACLE TECHNOLOGIES, INC.** represented by its Authorized Representative, **Ms. RISSA MAE J. TULAGAN**, duly organized and existing by virtue of the laws of the Republic of the Philippines with office address at No. 52 8th Avenue, West Grace Park, Caloocan City, hereinafter called the **"SUPPLIER"** of the other part.

WHEREAS, PNU being the National Center for Teacher Education embarks on a comprehensive modernization and upgrading program of its facilities;

WHEREAS, one of the areas that need to be given urgent attention is the building management system of the University;

WHEREAS, a Building Management System (BMS) is a control system that can be used to monitor and manage the mechanical, electrical and electromechanical services in a facility that includes power, heating, ventilation, air-conditioning, physical access control, pumping stations, elevators and lights;

WHEREAS, the 4 basic BMS basic tasks are Electric power control - control and monitor core electrical and mechanical equipment; Heating - schedule the system on and off; maintain a set temperature point; Ventilation - adjust based on occupancy controls; and Security and observation - access control; surveillance and intrusion detection;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply, Delivery, Configuration, and Installation of Building Management System (GD 2022-11-153)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty-Four Million Nine Hundred Sixty-Eight Thousand Pesos (P 24,968,000.00)**, hereinafter called the **"CONTRACT PRICE"**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security;
- (d) Notice of Award of Contract; and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Twenty-Four Million Nine Hundred Sixty-Eight Thousand Pesos (P 24,968,000.00)** or such other sums as may be ascertained, **PINNACLE TECHNOLOGIES, INC.** agrees to **Supply, Delivery, Configuration, and Installation of Building Management System** in accordance with his/her/its Bid.
4. The **Philippine Normal University** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

WHEREAS, the **CONTRACTOR** has offered his services to **ENTITY** and the latter is willing to accept the services of the former under such terms and conditions prescribed under this contract.

WHEREAS, the following documents, hereinafter referred to as Contract Documents, shall be deemed integral parts of this Contract, as fully as if hereto attached or herein stated, and shall continue to govern and control in full force and effect, the rights and obligations of the parties as if the documents were set forth in full, except as otherwise modified by mutual agreement in writing of both parties, to wit;
