- c. Performance Securing Declaration (PSD) as provided under the Revised Implementing Rules and Regulations of Republic Act No. 9184.

Failure to provide the performance security shall constitute ground for cancellation of the award and forfeiture of the bid security.

WHEREAS, during the Technical Evaluation conducted by the Technical Representative, **Sundria Airconditioning Services** failed to comply and satisfy the Eligibility Documents, particularly the requirements specified in Section VII. Technical Specifications;

WHEREAS, on **21 February 2023 (Tuesday)**, **Sundria Airconditioning Services** was formally issued a Notice of Non-Compliance thru email which was subsequently acknowledged receipt by the said bidder on **27 February 2023 (Monday)** also thru email;

WHEREAS, during the detailed Technical Evaluation conducted by the Technical Representative, **Sun Valley Multi-Purpose Cooperative** complied and satisfied all the requirements specified in Section VII. Technical Specifications of the bidding documents;

WHEREAS, upon arithmetical computation, **Sun Valley Multi-Purpose Cooperative's** Financial Bid amounting to **One Million Five Hundred Eighty-Five Thousand One Hundred Fifty-Eight Pesos and Seventy Centavos (Php 1,585,158.70)** with an equivalent of 15.60% (**₱ 293,075.90**) variance from the ABC for was then declared as the Lowest Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, on **8 March 2023 (Wednesday)**, the BAC, Technical Working Group (TWG), and BAC Secretariat conducted the Post Qualification assessment on the submitted bids by **Sun Valley Multi-Purpose Cooperative**, and was found to have complied with all the requirements and conditions specified in the bidding documents and have passed the post qualification after having verified, validated and ascertained its bid documents;

WHEREAS, upon careful examination, verification and validation of the eligibility, technical and financial requirements submitted by **Sun Valley Multi-Purpose Cooperative**, its bid of **One Million Five Hundred Eighty-Five Thousand One Hundred Fifty-Eight Pesos and Seventy Centavos (Php 1,585,158.70)** was found to be responsive;
