WHEREAS, the Philippine Normal University, in compliance with RA 9184, posted/advertised the Invitation to Bid for the **Rebidding for the Renewal of License of the Online Office Suite (Cloud Computing, Productivity & Collaboration Tools, Software and Products)** of Philippine Normal University on May 24-June 13, 2023 in PhilGEPS, PNU BAC Bulletin Board and PNU Website with an approved budget of **Two Million Five Hundred Thousand Pesos (Php 2,500,000.00)** for the contract;

WHEREAS, a **Pre-Bid Conference** was conducted last **31 May 2023 (Wednesday)** virtually via Goggle Meet application, wherein four (4) interested suppliers attended the Conference, namely:

WHEREAS, the Technology-Related Bids and Awards Committee (BAC) has scheduled and conducted the **Opening of Bids** on **13 June 2023 (Tuesday)** at 3:00 PM held at the Pedro T. Orata Hall (Room 103);

WHEREAS, during the scheduled Opening of Bids, two (2) suppliers bought the Official Bid Documents, and submitted Bid, namely: **LaQuest Philippines, Inc.** and **MaroonStudios, Inc.**;

WHEREAS, on **26 June 2023 (Monday)**, **LaQuest Philippines, Inc.** was formally issued a Notice of Non-Compliance thru email which was subsequently acknowledged receipt by the said bidder on **27 June 2023 (Tuesday)** also thru email;

WHEREAS, during the detailed Technical Evaluation conducted by the Technical Representative, **MaroonStudios, Inc.** complied and satisfied all the requirements specified in Section VII. Technical Specifications of the bidding documents;

WHEREAS, upon arithmetical computation, **MaroonStudios, Inc.**'s Financial Bid amounting to **One Million Nine Hundred Ninety-Four Thousand Four Hundred Ninety-Six Pesos (Php 1,994,496.00)** with an equivalent of 20.22% (**₱ 505,504.00**) variance from the ABC was then declared as the Lowest Calculated Bid, subject to further evaluation to ascertain, verify, and validate the submitted bid;

WHEREAS, upon careful examination, verification and validation of the eligibility, technical and financial requirements submitted by **MaroonStudios, Inc.**, its bid of **One Million Nine Hundred Ninety-Four Thousand Four Hundred Ninety-Six Pesos (Php 1,994,496.00)** was found to be responsive; and

NOW, THEREFORE, WE, the Members of the Technology-Related Bids and Awards Committee do hereby RESOLVE as it is hereby RESOLVED:

- a. That **MAROONSTUDIOS, INC.** be declared as the Lowest Calculated Responsive Bid, in consideration of its total amount of Bid equal to **One Million Nine Hundred Ninety-Four Thousand Four Hundred Ninety-Six Pesos (Php 1,994,496.00)**;
- b. That we, the members of the Bids & Awards Committee (BAC), as per Special Order No. 113, Series of 2023 dated 15 May 2023, recommends to the Head of the Procuring Entity (HoPE) to award the Contract as detailed in this BAC Resolution;
- c. That, a **Notice of Award (NOA)** be issued to **MAROONSTUDIOS, INC.**, upon adoption and approval of this BAC Resolution; and
- d. To recommend the foregoing for the approval of the President of the Philippine Normal University.

Failure to provide the performance security shall constitute ground for cancellation of the award and forfeiture of the bid security.



CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made the day of JUL 19 2023, 2023 between the **PHILIPPINE NORMAL UNIVERSITY (PNU)** of the Philippines represented herein by its President **Dr. BERT J. TUGA**, with Office address at PNU, Taft Avenue, City of Manila, hereinafter called the “**ENTITY**” of the one part and **MAROON STUDIOS, INC.** represented by its Business Development Manager, **Ms. CARLA JEAN CRUZ**, duly organized and existing by virtue of the laws of the Republic of the Philippines with office address at 145 Mother Ignacia Avenue, South Triangle, Quezon City, hereinafter called the “**SUPPLIER**” of the other part.

WHEREAS, starting July 2022, Google will implement major changes about the access to the different features including limitations in the storage capacity;

WHEREAS, based on the University's current figures, the institutional account exceeds the capacity of 100TB wherein it already has 162TB of storage which contains 1.9 million varied documents;

WHEREAS, in order for the University to maintain and better manage our Google Workspace, PNU needs to upgrade its account to “Education Plus” to provide additional space and at the same time, assist the Management Information System Office (MISO) in terms of managing storage in each PNU Gmail account/s, as well as giving additional features and functions that can be used for online learning; and

WHEREAS, the Entity invited Bids for certain goods and ancillary services, *viz.*, **Rebidding for the Renewal of License of the Online Office Suite (Cloud Computing, Productivity & Collaboration Tools, Software and Products) of Philippine Normal University (GD 2023-04-046a)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Nine Hundred Ninety-Four Thousand Four Hundred Ninety-Six Pesos (Php 1,994,496.00)**, hereinafter called the “**CONTRACT PRICE**”.

(b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


