ACTIVITIES CONDUCTED FOR ACADEMIC YEAR 2016-2017 AND 2017-2018

Psychological Testing and Profiling

As part of the developmental program for the ESGP-PA grantees, Psychological Testing and profiling is being conducted. The test takers include the original batch and the new/replacement grantees. Three tests were administered to ESGP-PA students. These are the Needs Assessment Survey and the other two were psychological tests, namely: Manchester Personality Questionnaire (MPQ) and Self Directed Search (SDS).

The first test administered was the PNU Needs Assessment Survey, which was provided by OSASS. It is a 45 item survey tool which aims to identify the current needs of the ESGP-PA students. It was written in a Likert form and has 4 options: Very Important (4), Important (3), Less Important (2), and Not Important (1). It is also further divided into categories such as: Academic Development, Career Development, Personal Development and Family/Social Development. Each category has 10 items which were anchored on the National Competencies needed to be acquired by each student as prescribed by the American School Counseling Association (ASCA). Identifying and addressing these needs have seen to be beneficial to students in terms of helping them cope with the detrimental effects of unaddressed needs to their learning and daily living.

The second test is the Manchester Personality Questionnaire (MPQ) Factor Version 14. It is relatively adopted from the Big-Five Factor Model of personality which was currently regarded as the most current, valid and reliable means of assessing personality at present. MPQ was developed to provide an occupational personality test which will focus on traits relevant to creative and innovative behavior. Since creativity has seen to have an increasing importance in personnel processes such as recruitment and training, as well as in the implementation and management of change, this test aims to assess creativity within a broad framework of personality dimensions.

The third test is the Self Directed Search (SDS) by John Holland et. Al. It is a self-administered, self-scored and self-interpreted career counselling tool. This guide to educational and career planning tool aims to give the test taker an assessment of their history of occupational preferences and especially the most recent preferences, which were identified as good estimates of what the person will choose or do next.

The interpretations of the above-mentioned tests were given back to the grantees and were utilized in the development of various developmental activities.

Workshop for ESGP-PA Grantees: Awakening the Assertiveness in "U"



An Assertiveness workshop was held last December 7, 2016 for the ESGP-PA grantees. Assertiveness is one of the much-needed yet undeveloped personal quality among Filipinos. This can be attributed to our characteristics of being patient, understanding and respectful that we do not want to have

conflict with other people especially with the authorities. However, most of the time, we fail to fight for what is right because we opted not to say what we want to say.

ESGP-PA grantees, in particular, need to develop and enhance their assertiveness as this will benefit them in the future, especially in the workplace. Assertiveness is a way to build "win-win" situations among people. Assertive people can be good problem solvers and are good at communicating within all levels in the organization and they are also able to accomplish things more confidently. The workshop was facilitated by Ms. Nelia D. Ong and Gladys Aviles, interns of MAEd Guidance and Counseling. They were also the key persons in the development of the program for ESGP-PA grantees.





A special program was held for all SGP-PA graduates who took and passed the Licensure Examination for Teachers last September 2016. This was

attended by all ESGP-PA Grantees enrolled in the university. The event was held at the Geronima T. Pecson Building as part of the University Month Celebration. Among the scholars who took the exam, 10 of them passed the Board Licensure Examination for Professional Teachers (BLEPT) held last September 25, 2016. An invitation to give an inspirational message to the new professional teachers was given to **Mr. Andrew Leyson**, the Regional Director of Department of Social Welfare and Development- National Capital Region (DSWD-NCR). The tribute was made more memorable because of the presence of Ms. April C. Co, focal person for DSWD-NCR, Manila.
