I. Invitation to Apply for Eligibility and to Bid

**SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION
OF ON-PREMISE UNIFIED ENDPOINT MANAGEMENT (UEM)
ENTERPRISE SOFTWARE SUBSCRIPTION FOR THE
UNIVERSITY**

1. The **Philippine Normal University**, through the **GAA 101 2025** intends to apply the sum of **Two Million Four Hundred Thousand pesos and 00/100 only (Php 2,400,000.00)** being the ABC to payments under the contract for **Supply, Delivery, Installation and Configuration of On-Premise Unified Endpoint Management (UEM) Enterprise Software Subscription for the University (GD 2025-02-034)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Normal University** now invites bids for the above Procurement Project. Delivery of the Goods is required by **Forty-Five (45) Calendar Days**. Bidders should have completed, within **Three (3) Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **PNU BAC Secretariat** and inspect the Bidding Documents at the address given below during **7:00 A.M. - 4:00 P.M. (Monday-Friday)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 25-March 17, 2025** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Two Thousand Four Hundred pesos (Php 2,400.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

9. Bid opening shall be on **March 17, 2025 (Monday); 11:00 A.M.** at the **Pedro T. Orata Hall (Room 103)**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Philippine Normal University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
