WHEREAS, the Philippine Normal University, in compliance with Republic Act No. 9184, posted and advertised the Invitation to Bid for the **Supply and Delivery of Various IT Equipment for FY. 2026** from December 2-22, 2025, through PhilGEPS, the PNU BAC Bulletin Board, and the PNU Website, with an approved budget of **Eight Million Five Hundred Eighty Thousand Pesos (₱8,580,000.00)** for the contract;

WHEREAS, a **Pre-Bid Conference** was held on **December 9, 2025 (Tuesday)**, at the Edilberto P. Dagot Hall (Multimedia Room), attended by two (2) interested suppliers, as follows:

1. **Philcoryou Trading Corporation**, represented by Mr. John Albert Qutorio (qutorio@pcgreen.ph)
2. **Power Mac Center, Inc.**, represented by Mr. Krisstofe Quemquem (krisstofe.quemquem@powermaccenter.com)

WHEREAS, the Technology-Related Bids and Awards Committee (TR-BAC) scheduled and conducted the **Opening of Bids** on **December 22, 2025 (Monday)** at 8:00 A.M. at the Edilberto P. Dagot Hall (Multimedia Room);
