Invitation to Bid for Rebidding for the Repair and Improvement of Commercial Stalls along San Marcelino

- 1) The **Philippine Normal University**, through the **STF 164 2026** intends to apply the sum of **Eight Million Six Hundred Sixty-One Thousand Four Hundred Thirty-Seven Pesos (₱8,661,437.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Rebidding for the Repair and Improvement of Commercial Stalls along San Marcelino (CW 2026-06-007)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **Philippine Normal University** now invites bids for **Rebidding for the Repair and Improvement of Commercial Stalls along San Marcelino**. Completion of the Works is required **One Hundred Eighty (180) Calendar Days**. Bidders should have completed, within **Ten (10) Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found. (ITB)**.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from **PNU BAC Secretariat** and inspect the Bidding Documents at the address given below from **7:00 A.M. - 5:00 P.M. (Monday-Tuesday, Thursday-Friday)**.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **June 30-July 20, 2026** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Eight Thousand Six Hundred Pesos (₱8,600.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The **Philippine Normal University** will hold a Pre-Bid Conference on **July 7, 2026 (Tuesday); 11:00 A.M.** at **Edilberto P. Dagot Hall (Silid Ugnayan)**, which shall be open to prospective bidders.

- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below, on or before **July 20, 2026 at 10:30 A.M.** Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9) Bid opening shall be on **July 20, 2026 (Monday); 11:00 A.M.** at **Edilberto T. Dagot Hall (Silid Ugnayan)**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The **Philippine Normal University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
